Release of Liability and Indemnity Agreement

I, the undersigned, (Handler) voluntarily provide this release of liability and indemnity agreement to PAWSITIVE LEARNING, dog training & behavior solutions, Filomena Diaz-Johnson (Instructor) and any other persons, assistants, agents, officers, officials, properties, or corporations related to, owned by, or associated with instructor to release and indemnify instructor from any and all liability occasioned by handler and handler's dog in and around training classes and the property in which it is conducted.

The Handler realizes the risks and dangers associated with training of dogs and related Handler activities that might be conducted during said training course. The Handler realizes that unanticipated and unexpected dangers, both of natural and man-made origin, may occur during class. The Handler assumes all risks of injury (of any kind) to the person, dog, and property of the Handler and likewise, to the person, dog, and property to those in the Handler's presence in and around conducted class.

The Handler, for (him/her) self, dog, employees, charges, heirs, and administrators, assigns, releases, remises, and discharges Instructor and related parties from all claims, demands, actions, and causes of action of any sort for injury sustained to the person and/or property of the Handler during his/her presence in class due to strict liability, negligence, or any other fault. The Handler also agrees to indemnify, defend, and hold Instructor harmless should Instructor be found to be obligated, including reasonable fees and costs of suit, in the event of any claim, suit, or action, arising from or occasioned by the Handler's presence in or around class.

This Release of Indemnity Agreement does not constitute permission for the Handler and dog to be in class. Likewise, this release and indemnity agreement does not signify that any type of contractual agreement or other legal relationship exists between the Handler and Instructor.
